Financial Grant Requests -

Manual JFL – Tony Ware. Football and cheerleading. Ages 5-14. 111 boys. 28 girls. \$140 registration fee. \$700 requested. Funds requested include: "To purchase new helmets and equipment." Last grant awarded: None in the last fiscal year. Motion by Jeff Doeden to approve \$500, second by Regan Jones.

Canton All-Stars Travel Softball Association – Jonathan Lee. Softball. Ages 5-13. 0 boys. 70 girls. \$200 registration fee. \$700 requested. Funds requested include: "Our intention is to use the money to help players with their fees. The county we live in has a high poverty rate and parents have a difficult time in paying for fees. We attempt to fundraise and find sponsorship to help players with these fees, but sometimes it is not enough with the amount of girls in the program. We would use this money towards scholarships for the players." Last grant awarded: None in the last fiscal year. Motion by David Hunt to deny, second by Jeff Doeden.

Canton JFL – Matt Powell. Football. Ages 5-14. 165 boys. 60 girls. \$150 registration fee. \$700 requested. Funds requested include: *"Fulton County has a very high poverty rate and we have several athletes that rely on scholarships in order to play football or cheer. Limestone Youth Baseball Inc – Joe Dicce. Baseball. Ages 4-14. 300 boys. 25 girls. \$100 registration fee. \$700 requested. Funds requested include: *"We intend to use the funds to purchase new catcher mitts and gear for our in-house program during the offseason. We encourage our teams to rotate catchers and therefore provide these items to each team. We have a few sets that are appropriate but at this time not enough for each team to have decent gear."* Last grant awarded: None in the last fiscal year.
